### **VISITORS TO TRANSIENT CAMPERS:**

- **Adult Day Pass** - 9:00 a.m. to 11:00 p.m. /;'. **\$5.00** +HST
- **Adult Overnight Pass** (staying in your unit) **\$15.00** +HST/ night
- **Child Pass** (under 18 yrs of age) day or overnight **No Charge**

**ALL VISITORS:** are required to **STOP** and **REGISTER** at the office. It's imperative in the event of an unforeseen emergency that we know who is on the grounds at all times.

- Visitors must be visiting a registered camper and follow the rules of the campground
- Visitor vehicles must display a current day or overnight pass, including those parked in the designated parking area by the gate.

**CHECK IN / CHECK OUT:** Check in: 2 pm, checkout: 12 noon. If you require an early or late check in/ check out time, arrange that ahead of time with the office. Leave your site clean when you leave. Garbage bins are provided. Dump station is located at the back of the main building.

**POOLS:** Open at 10 am and close at dusk. Follow the posted signs. Use at own risk, no lifeguard on duty. Maximum of 10 people in each pool enclosure at one time. Limit swim times to allow others to use the pools. No pets, drinks, alcohol, food, electronics, toys or large floats in the pool enclosures. Children under 12 and non-swimmers must be supervised by a responsible person not less than 16 years of age.

**QUIET TIME:** is 11:00 pm - 8:30 am. Keep your music low or off and voices at a quiet conversation level. Be a good neighbour, respect other campers.

**SPEED LIMIT:** Speed limit on the campground is a maximum of **10 km/hr**.

**BICYCLES:** Helmets are REQUIRED for kids under the age of 18. It's the law. All bicycles must be parked back on their sites by dusk and remain there until morning.

**ALCOHOL:** No open alcohol or glass containers off your site.

**PETS:** Dogs are required to be on a leash and secured when on your site. The dog park is the only area they can run. Clean up after your pet and dispose of in the containers provided. No aggressive dogs or excessive barking. Never leave your pet unattended.

**CHILDREN & YOUTH:** Parents and guardians of minors are solely responsible for their supervision, actions, and behavior. Minors must be back on their sites by 11:00 p.m.

**PLAYGROUND:** Follow the signs posted. Playground equipment is off-limits after dark.

**GAMES:** No charge for equipment loans for games to keep your family entertained. Golf, pickleball, basketball, sand volleyball, baseball, badminton, lawn Yahtzee, puzzles, books, board & card games, pool table, ping pong and more. Ask at the office.

**TRAILS:** 4 km of groomed trails for walking, hiking, bird watching, bicycles and golf carts. See map posted on the chalet or copies of the map are available at the office. Keep the trails clean, no litter.

**GOLF CARTS & ATVS:** No ATVs, go-karts, dirt bikes, or other gas-powered recreational vehicles. Electric golf carts for weekend or short-term stays must be pre-approved by management prior to arrival. Preapproval is based on the owner having mobility issues and is the ONLY one permitted to drive the golf cart during your stay. Campground golf cart rules apply.

**WIFI:** is available in the vicinity of the main building and at the pavilion. Password: shadypinesguest



**EMERGENCY & FIRST AID:** An AED defibrillator is on site. Most staff are Red Cross Certified in First Aid, can take charge or assist in an emergency. Minor injuries can be treated at the office.

**IN A MEDICAL EMERGENCY: Stay calm. Dial 911 for an ambulance,** location is Shady Pines Campgrounds, 11316 Petty Street, Ailsa Craig and give them your location within the park. Call for help and send someone to notify the Staff on Duty (after hours names/numbers are posted on the main building bulletin board). Stay calm and begin first aid measures, reassure the patient that help is on the way. If unconscious, roll them into the recovery position on their side to keep their airways open. An emergency phone is located by the public washrooms at the main building.
